FRED FARR HAS THE EXPERIENCE FRED FARR CAN BE EFFECTIVE



A widower, Fred has a married son Sam, who is a law student and a former Peace Corps Volunteer, and his daughter Francesca teaches school in a Boston ghetto. Fred Farr's life and leadership have been a part of Monterey County for many years. He is an Eagle Scout and a member of Rotary, Elks, and the Commonwealth Club. He is also an honorary life member of the Sierra Club, has been active in the PTA, and is presently chairman of the Urban Environment Committee of the American Bar Association. He has served as president of the Monterey County Tuberculosis and Health Association, and has been a

director of the Red Cross and Community Chest and is now a Director of the National Student Conservation Association in New York and the Thorne Ecological Foundation in Colorado.

Fred Farr has won national attention in creating legislation dealing with conservation He has authored important legislation concerning law enforcement, better schools, juvenile courts, veterans and senior citizens. He was commended in the Saturday Evening Post for having caused the Attorney General to investigate the Hell's Angels. At the invitation of President Eisenhower, he was a delegate to the 1960 White House Conference on Children and Youth and was also chairman of the panel on Scenic Roads and Parkways at the 1960 White House Conference on Natural Beauty



## FRED FARR LOVES MONTEREY COUNTY

Former State Senator Fred Farr served Monterey County for 12 years in Sacramento. His valiant efforts on behalf of conservation legislation gained him the reputation of being "one of America's outstanding conservation leaders." He has consistently worked to preserve the natural beauty of Monterey County and to protect us from the infringement of outside interests. The Readers Digest cited him as "one of the savers of the Big Sur"

It is because of his love for Monterey County and a desire to serve his former constituents that Fred Farr resigned his position as Coordinator of the Highway Beautification Program in Washington to come home and seek the 34th Assembly District seat that was vacated by the unfortunate death of Assemblyman Alan G. Some examples of his legislative accomplishments for our County are

- Authored legislation creating Asilomar State Conference Grounds.
- Obtained \$3,600,000.00 for San Antonio Dam and recreation area.

- Authored legislation protecting underwater marine areas at Point Lobos and Pacific Grove.
- Obtained unemployment insurance for California fishermen
- Authored legislation requiring field sanitation for agriculture workers.
- Obtained state aid for Boys Ranch in Salinas.
- Authored legislation creating State College marine laboratory at Moss Landing.
- Fought the big oil interests from polluting our air and damaging our crops and beaches.
- Authored legislation for low cost housing in the County
- Authored specific measures for stronger law enforcement procedures.
- Authored legislation providing state aid for senior citizens facilities.
- He gained nationwide attention by winning a test case giving the right to vote to persons living on military posts a Victory for democracy for 50,000 Californians.
