

Third General Meeting --- Thursday, March 21, 1935

8:30 PM.

At the Japanese Language School, Monterey.

Meeting was called to order by Pres. Sakamoto. He explained that this meeting was called for the special purpose of studying the Anti-Alien bills before the Legislature and to determine our policy in regards to them. Minutes of the last general meeting was read by Sec. Tabata, corrected by Ass't Sec. Higashi, and approved by the President and the members.

Ass't Sec. Higashi moved that we purchase an American Flag for club use. Mr. Suyama made an amendment to the motion that we table this matter until we can refer it to the Finance Board and find out how much such a Flag would cost. Mr. Takiguchi seconded the motion.

Both Motions carried.

Ass't Sec. Higashi announced that Mr. Esaki had requested another appointee to the Public Relations Board and made known that Mr. Oka was duly appointed as the third active member. Sec. Tabata announced that Ass't Sec. Higashi was appointed by Vice Pres. Esaki to head the Board.

Pres. Sakamoto asked Mr. Suyama to have her sister announce the members of the Social Board as soon as possible.

Previous discussion about the Tea Party was brought up and Mr. Suyama moved that we table this matter indefinitely. Sec. Tabata seconded. Motion carried.

Previous discussion regarding the Callendar for the Year was brought up for consideration. Mr. Suyama moved that the Executive Board prepare such a callender from the experience of previous year. Miss Ogawa seconded the motion. Motion carried.

Pres. Sakamoto requested Ass't Sec. Higashi to give detailed report on special session at San Francisco March 10 regarding the Anti-Alien bills.


