California Private Land Grant Records

The records of the California private land grants, 1770's - 1847, which formed part of the Spanish Archives of Provincial California and which were scattered in different locations after the American conquest in 1846, were collected by Edwin M. Stanton (later of Lincoln's cabinet) in 1858 for the prosecution of the fraudulent Limantour claim. By this year, 1858, all the extant records of the Spanish Archives including the land grant papers had been collected and deposited with the U.S. Surveyor General for California in San Francisco. In the 1906 San Francisco fire all the records of the Spanish Archives were burned except those land grant papers and a few others stored in the iron safe (installed 1879). The surviving grant papers were transferred to the U.S. Land Office in Glendale in 1932. In 1936 the U.S. District Court judges requisitioned the Glendale private land grant records to be transferred to San Francisco to become part of the District Court private land grant cases; the requisition was referred to the Washington office which, in 1937, ordered the papers sent to the National Archives for repair. In two years the repairing had been completed, and apparently the registration of the District Court was forgotten, for in 1939 the records were transferred to the ownership of the National Archives.

The private land grant papers in the Archives comprised the following: Expedientes (The papers in the case) contained petitions for grants, references and informes, litigations, concessions, actions of Department Assembly, Titalos, juridical possessions, Diseños, etc. There were 580 -- one number was used twice. Unclassified Expedientes: petitions and other papers for grants on most of which final action was not taken; also the grants in Baja California, and a few in the province but which were not claimed after 1846. They numbered 315. R.C. Hopkins, long Keeper of the Archives, called them unclassified and sometimes incomplete; in his certified transcript for the State in 1866-71 he designated them unclassified. Filed Expedientes: These 187 records were filed with the Board of Land Commission, 1852-56, in support of the claims; when the Board ended its work in 1856 the records were transferred to the Archives. Deposited Expedientes: petitions, correspondence, boundary disputes, etc., relating to cases before the Board; in 1856 they were also transferred to the Archives. In 1870 there were 21 yet in 1880 27 were reported. Tomas de Razon (Registers of grants): The first, 1784-1831, was part of the General Archives; No. 2, 1833-36, was in the forms of copies of 103 Titulos in the Archives; No. 3, 1836-38 was lost; No. 4, 1839-43, items 1 - 196, was reported in 1851 as burned in the S.F. fire of that year but it was found in 1914, identified in 1942 and is now in the State Library; No. 5, 1841-43, incomplete for those years, was burned in 1906 and no transcript has been found; No. 6, 1844-45, items 197 - 317, was a continuation of No. 4 and was transcribed for the State's Spanish records; Nos. 7 and 8, 1846, were unbound books and were lost in 1846, so never became parts of the Archives.

The California private land grant records are now (1956) located in the following places: U.S. District Court, S.F., State Archives and State Library, Sacramento, the Bancroft Library, Berkeley, National Archives, and a few in pri-

vate hands. There are three exceptions: The claim for Prietos y Najalayagua in Santa Barbara County was made directly to Congress which finally approved it for patent; the expediente of the grant (12 pages, 1 diseño) is now in the National Archives but not part of the private land grant collection. The claim for the Island of Yerba Buena in San Francisco Bay was also made directly to Congress which later rejected it for patent; the National Archives is unable to locate the expediente which accompanied the claim. The papers of the Eugenio Macnamara grant were taken to Washington by Fremont in 1846 were never returned; the National Archives is also unable to find the present location of the expediente if it still exists.

In the U.S. District Court clerk's office, 355 P.O. Building, San Francisco, are the private land grant cases brought before the Northern and Southern District courts and the Circuit Court, 1852 to 1942, in which latter year, in all probability, the last land grant litigation was finally ended. In 1866 on the closing of the District Court in Los Angeles all the court records (all were land cases except three) were transferred to the Northern District Court in San Francisco where they still remain. The cases contain (1) transcripts of the records before the Board of Land Commissioners (except 19 claims which were not appealed, and 16 of these 19 were carried in and through the District Court by related cases) with translation of almost all the Spanish records filed in each case, and (2) all the court records -- testimony, depositions, maps, surveys, decrees, etc. There are 852 cases as numbered. During the decades only one case has been lost (San Gerónimo, 283 ND, in Marin County); the Board transcript for it has been replaced by photostats from Washington, but the District Court papers, etc., are not replaceable. With these cases are the two Dockets, the Minute Books, and the Judgment Books except one volume which has long been lost.

In the State Archives, Sacramento, are the Spanish Archives composed of eight volumes of certified transcripts, eight volumes of translations, and two volumes of diseños of the private land grant records as they existed in 1866-71 when they were made on the authorization of the Legislature. They contain the Expedientes. Unclassified Expedientes, Filed Expedientes, Deposited Expedientes, Titulos, and Toma de Razon (1844-45).

In the State Library, Sacramento, is the Toma de Razon, 1844-45, bought in 1914 and identified in 1942. It preceeds the Toma in the Spanish Archives transcripts in the Capitol Building.

In the Bancroft Library, University of California, Berkeley, is Bancroft's copy and transcripts of the Register in the General Archives in vol. 63 of his abstracts of the Archives made in the 1870's. It contains the Register or Toma from 1784 to 1831.

In the National Archives (since 1939) are the original private land grant records as they survived the 1906 San Francisco fire -- Expedientes, Unclassified Expedientes, and Board Expedientes; the National Archives calls them respectfully Complete Expedientes, Incomplete Expedientes, and case Expedientes. All three sets of these records have been laminated, with those four-page sheets (8 1/2 x 12 1/2 inches) flattened out into one sheet (12 1/2 x 17 inches). They are filed in flat folders made of heavy brown papers folded into pockets, sealed and appro-

privately labeled.

The present records in the National Archives are those originals which survived the use during the decades and the 1906 fire. Of the records in the iron safe in 1906 about 10% were reduced to ashes and so are a total loss, and include the parts of the records listed below, all the Filed Expedientes, Deposited Expedientes, Titulos, and Tomas de Razon. Of the original 879 expedientes, 315 Unclassified Expedientes and 809 Board Expedientes, 437 or over 25% have been lost, most of which are of the last group. The surviving records are listed below with the number of pages and number of diseños each.

Misplaced records. By 1885 98% of the claims presented for patent had been decided by the Government; since that date the records have diminished in use as legal papers while the historical research use has increased correspondingly. Since 1885 the researchers have evidently not been as careful as the Archives clerks in refiling used papers; hence some misplaced records. In September-October, 1955, over 30 diseños were found misfiled in wrong files a few folders away from the proper one. This could possibly have happened anytime since 1852 but most probably since 1885 and the present. It is quite possible that other papers than diseños may also be misfiled.

Condition. All the private land grant papers show the effect of the heat of the 1906 fire. Volumes 18 - 21 of the Expedientes (Nat. Arch.: Complete Expedientes) as they were filed in Glendale were very badly charred; some so badly that the National Archives has made no effort to handle them; some were blackened but were such that they could be and were laminated. In one case photostats were made of these blackened records -- the reproduction is blank. In all these laminated records only one was found with the foil beginning to loosen from the face of the paper.

Photographic Reproduction, negatives, 1956. U.S. District Court records and maps, 8 $\frac{1}{2}$ x 10 $\frac{1}{2}$ are photostated at 23¢ per page, 8 $\frac{1}{2}$ x 11 at 29¢ per page, 24 x 11 at 82¢ per page; maps over the latter size can not be reproduced. State Archives records and diseños are photostated at 30¢ per page. National Archives records up to 17 x 11 are photostated at 40¢ per page; the very few records larger than this size (or 17 x 11 to 24 x 17) cost 75¢ per page. The National Archives can also microfilm the records (35 mm) at \$2.50 per 50 images.

Following is the list of the Expedientes, Unclassified Expedientes, and Board Expedientes with indication (1) of the number of pages and (2) of diseños of each. Lost indicates the absence of the expediente in the National Archives. Bad labels those expedientes badly charred by the 1906 fire and are wholly or almost wholly illegible. In a few cases there is only one page -- the title page (and not always the original), and in a few cases there is no title page and only a diseño.

The number of pages have been counted as follows: The pages are normally about 8 x 11 inches but many sheets double this size have been flattened and laminated as one sheet with one, two, three, or four pages bearing written matter. The unit is a page bearing any written entry whatever; blank pages are not counted. One title page -- the original -- is counted; duplicates are omitted. A few diseños which had been broken into two parts were laminated separately -- they are counted as one. A few broken diseños were laminated as one but the edges have been reversed.
