## PROP. 47 WILL SUPPORT CSUMB'S GROWTH

We've all left our mark in some way or another here at CSU Monterey Bay. I am now asking you to think about adding another achievement to our history. This November, Proposition 47, an issue vitally important to our university's future, will be on the ballot. Prop. 47, the "Kindergarten-University Public Education Facilities Bond Act of 2002," should get everyone's attention. If passed by the voters, the bond will provide \$13.05 billion to K-12 schools, colleges and universities for much-needed capital improvements.

The CSU system will get \$495.9 million, with CSUMB receiving \$15.29 million of this amount. The campus will benefit with an upgrade of our telecommunications infrastructure. The funds will also lead to a new library facility. Why a new library? Because the current facility will not accommodate future enrollment increases, let alone provide the resources needed in a top-quality university library.

Prop. 47 is the first of two bond requests to fund education projects which will be presented over the next four years. The second proposition will appear on the ballot in March 2004. If the 2004 bond measure is approved, the funds CSUMB receives from it will go toward library equipment and renovation of the academic complex.

Not only will Prop. 47 support university improvements, it will also benefit the schools where our alums teach, the schools where our children, nieces and nephews attend classes, and the schools where our grandchildren will be educated for decades to come. Unfortunately, many of our schools are overcrowded, need expansion, or require major structural repairs to make them safer. This bond measure will help those schools. To make sure the bond money achieves these objectives, administrators will be held accountable for its spending. The funds can only be used for capital improvements on campuses, not for salaries or programs.

How will passage of this bond measure affect our lives? Taxes will not be increased. Passage of Prop. 47 will leave our state's debt ratio at 4.24 percent, well within the 5 percent margin that Standard & Poor's (S&P) considers desirable. While conceding that inadequate school facilities are a serious problem, opponents of Prop. 47 argue that assuming more bond debt could harm the state's finances. They also believe the school construction process takes too long.

Although this measure may not seem important to some, California's students, educators and parents believe it is vital. I ask you to think about how the passage of Prop. 47 will favorably affect your local schools, the future of education, and the future leaders of our state — today's children of California. You can make a difference in education by voting for this measure. Please consider the significance of Proposition 47 when you vote this November.

### **CSUMB** SUPPORTS THE FIGHT

"It's about hope. It's about learning to cope. It's about taking up the fight. It's about finding a cure for cancer. It's called *Relay for Life*." That's the lyric of *Life Song* by Chris Bruton.

Each year the American Cancer Society holds an 18 to 24 hour *Relay for Life* walk to raise money for cancer research. The Monterey County chapter of the society held its second annual walk on campus at Freeman Stadium September 20-21. The event was conducted in many cities throughout the nation, including Salinas, Santa Cruz and Hollister.

This year, the Monterey *Relay for Life* raised more than \$70,000. Over 25 teams participated to raise money for cancer research. The "Beat-Alls" team consisted of CSUMB alums. The "Mammograms" team was made up of staff members and alums. These dedicated supporters walked in shifts throughout the foggy night to help fund the fight to cure cancer.

There's plenty of optimism that an effective treatment will be found, yet researchers are still seeking that elusive cure. If you're interested in

### NEW DEAN FOR AHSS

The Center for Arts, Human Communication and Creative Technologies (AHCCT) has both a new name and a new dean. It's now called the College of Arts, Humanities, and Social Sciences (AHSS) and its new dean is Dr. Barbara Mossberg. Most recently, Mossberg served as president of Goddard College in Vermont and as senior consultant to the

American Council on Education, Center for Institutional and International Initiatives. Mossberg was also awarded the Ersted Prize (University Distinguished Teaching Award) at the University of Oregon.

As dean of AHSS, Mossberg will provide leadership and advocacy for strategic and budgetary planning; faculty and staff recruitment, development and evaluation; curricular and fiscal management; enrollment planning, student recruitment and retention; program review; and accreditation. The new college includes the Human Communication, Global Learning,



Music and Performing Arts, Social and Dr. Barbara Mossberg Behavorial Sciences, Visual and Public Art,

and World Languages and Cultures institutes.

Mossberg received her Ph.D. in English from Indiana University, an M.A. from Indiana University, and a B.A. from UCLA.

### DEANSHIP FOR MARSHA MOROH

Dr. Marsha Moroh has become dean of the College of Science, Media Arts, and Technology, formerly the Science, Technology, and Information Resources center (STIR). She joined CSUMB in January 1995 as a founding faculty member and full professor in interdisciplinary studies. Moroh was instrumental in the development of the Institute for Communication Science and Technology (CST) and the Telecommunications, Multimedia, and Applied Computing (TMAC) major. In 1996, she assumed the interim dean position for the Center of Science, Technology, and Information Resources.

As the permanent dean of the College of Science, Media Arts, and Technology, Dr. Moroh will continue to provide leadership and advocacy for all phases of the college's operations, including student recruitment, retention and accreditation.

Dr. Moroh received a Ph.D. in computer science from Polytechnic Institute of New York, an M.A. in operations research from New York University, and a B.A. from Dickinson College in Pennsylvania. \*
