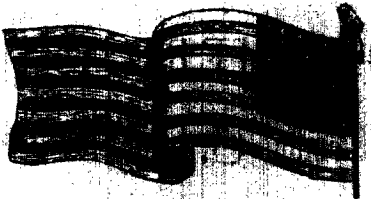

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the **GENERAL LAND OFFICE**,
Warrant No. *91408* for *80* acres, in favor of *Charles Stetins*

(Mar 1812)*

with evidence that the same has been duly located upon

*the West half of the South East
quarter of Section thirty four in Township twenty four south of Range
thirty East in the District of Lands subject to Sale at San Francisco
California containing Eighty Acres*

according to the Official Plat of the Survey of said Lands returned to the **GENERAL LAND OFFICE** by
the **SURVEYOR GENERAL**

*the said Warrant having been assigned by the said
Charles Stetins to Benjamin Brewster in whose favor said tract has
been located*

NOW KNOW YE, That there is therefore granted by the **UNITED STATES** unto the said
Benjamin Brewster as assignee as aforesaid and to his heirs

the tract of Land above described: **TO HAVE AND TO HOLD** the said tract of Land, with the appurtenances
thereof, unto the said *Benjamin Brewster as assignee as aforesaid and to his*

heirs and assigns forever.

PRESIDENT OF THE UNITED STATES OF AMERICA, have caused these Letters to be made Patent,
and the **SEAL OF THE GENERAL LAND OFFICE** to be hereunto affixed.

of *May* in the year of our Lord one thousand
eight hundred and *seventy*, and of the **INDEPENDENCE**
OF THE UNITED STATES the *thirty fourth*

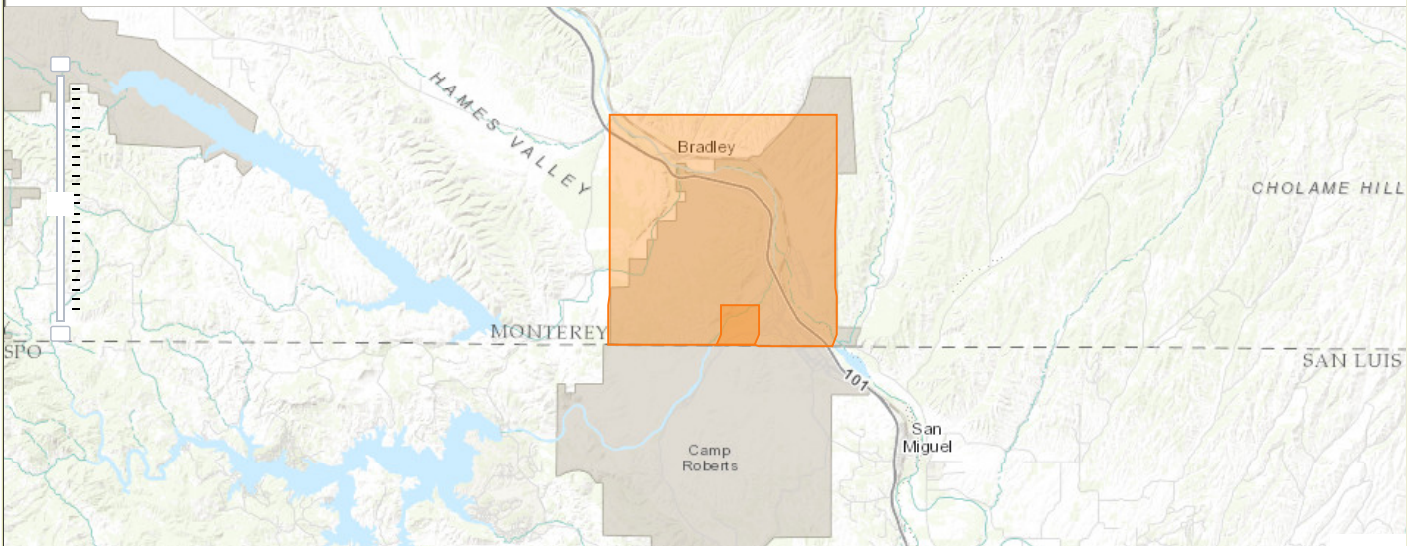
