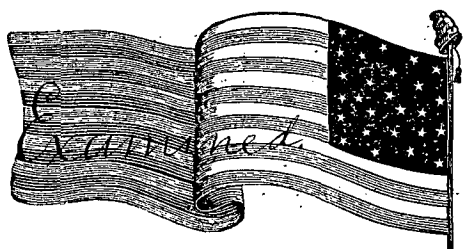

THE UNITED STATES OF AMERICA,

To all to whom these Presents shall come, Greeting:

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE,

Warrant No. *28712* for *120* acres, in favor of *Richard M. Robt Private Captain Richardsons Company Illinois Militia Black Hawk War.*

with evidence that the same has been duly located upon *the South West quarter of the North East quarter the West half of the South East quarter of Section Thirteen in Township Twenty four South of Range Eleven East Mount Diablo Meridian in the District of Lands subject to sale at San Francisco California containing one hundred and twenty acres.*

according to the Official Plat of the Survey of said Lands returned to the **GENERAL LAND OFFICE** by the SURVEYOR GENERAL *the said Warrant having been assigned by the said Richard M. Robt to Louisa Homalson in whose favor said tract has been located.*

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said *Louisa Homalson as assignee as aforesaid and to her heirs*

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said *Louisa Homalson and to her heirs as assignee as aforesaid and to her heirs*

heirs and assigns forever.

PRESIDENT OF THE UNITED STATES OF AMERICA, have caused these Letters to be made Patent, and the SEAL OF THE GENERAL LAND OFFICE to be hereunto affixed.

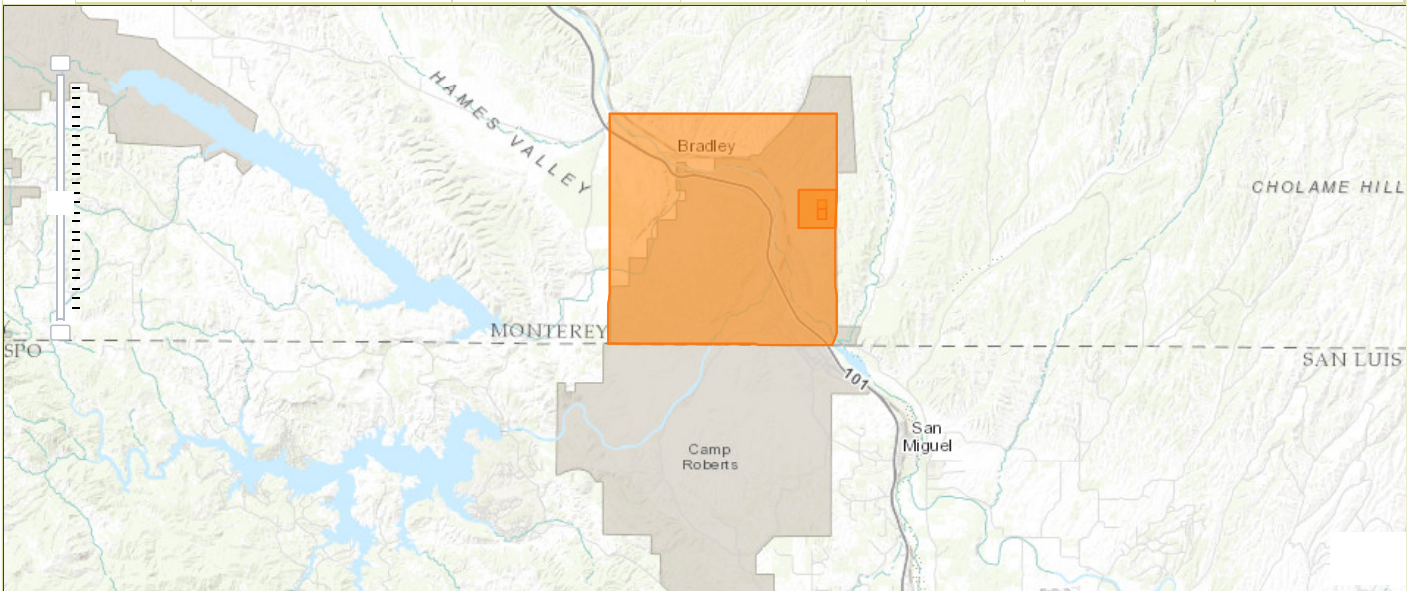
