To all to whom these Presents shall come, Greeting:

Whereas, In pursuance of the Act of Congress, approved September 28th, 1850, entitled "An Act granting Bounty Land to certain Officers and Soldiers who have been engaged in the Military Service of the United States," Warrant No. *73074* for *40* acres, issued in favor of *Isabella Armstrong Widow, of John Armstrong Private, in Captain Bader's company, Maryland Militia, Mar 1812*

has been returned to the GENERAL LAND OFFICE, with evidence that the same has been duly located upon the *the north east quarter of the south east quarter of section twenty five, in Township twenty five south of Range fourteen East, in the District of Lands subject to sale at San Francisco California containing Forty acres*

according to the Official Plat of the Survey of the said Lands returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL:

Now Know Ye, That there is therefore granted by the UNITED STATES unto the ~~said~~ *Heirs of the said Isabella Armstrong*

the Tract of Land above described: TO HAVE AND TO HOLD the said Tract of Land, with the appurtenances thereof, unto the ~~said~~ *heirs of the said Isabella Armstrong and to their*

heirs and assigns forever.

In Testimony Whereof, I, *Abraham Lincoln* PRESIDENT OF THE UNITED STATES OF AMERICA, have caused these Letters to be made Patent, and the SEAL OF THE GENERAL LAND OFFICE to be hereunto affixed.

GIVEN under my hand, at the CITY OF WASHINGTON, the *first* day of *July* in the year of our Lord one thousand eight hundred and *seventy* and of the INDEPENDENCE OF THE UNITED STATES the *thirty fourth*

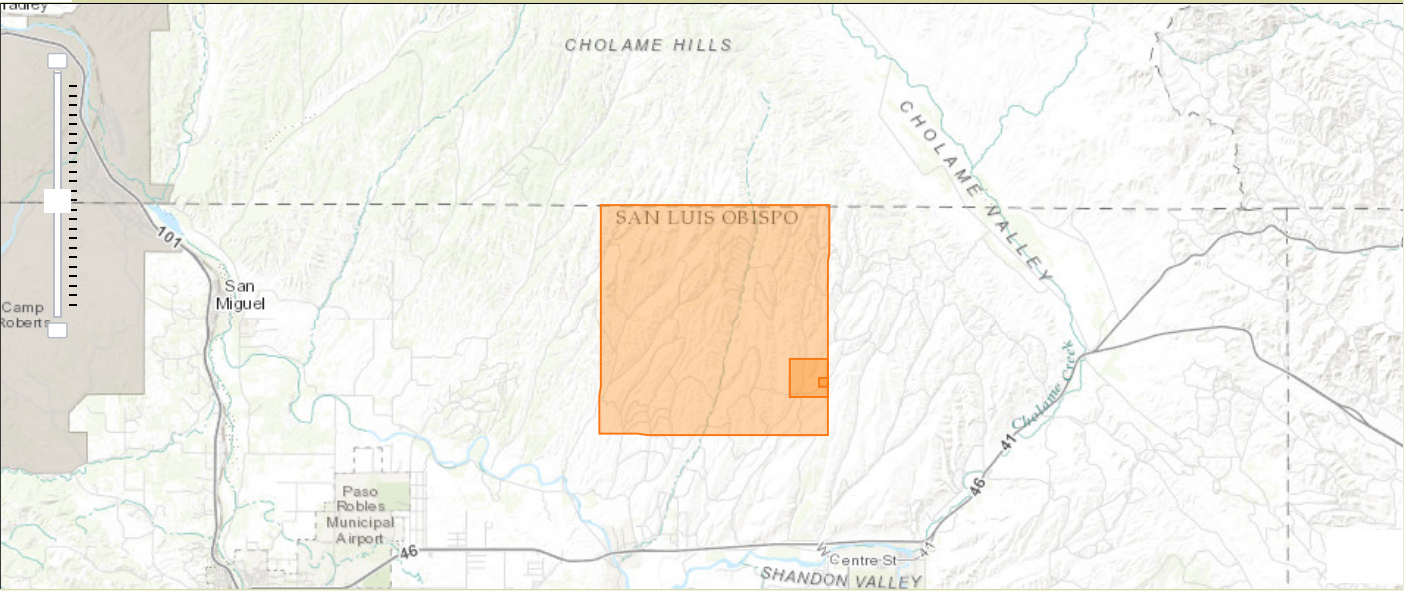
