To all to whom these Presents shall come, Greeting:

Know Ye, That in pursuance of the Act of Congress, entitled "An Act to raise for a limited time an additional military force, and for other purposes," approved February 11th, 1847.

Erasmus Bennett, Private, in Captain De Koyonoy's Company, 3^d Regiment of Missouri Volunteers, for One Hundred and Sixty acres of Land.

having deposited in the GENERAL LAND OFFICE a WARRANT in *his* favor, numbered *59401* for *160* acres

THERE IS THEREFORE GRANTED BY THE UNITED STATES, unto *John W. Mayberry, Assignee, of Crawford P. Teague, assignee of the said Erasmus Bennett, and to his heirs, the South East quarter, of Section Twelve, in Township Twenty seven, South, of Range Thirteen, East, in the District of lands subject to sale at San Francisco, California, containing One Hundred and Sixty acres.*

according to the Official Plat of the Survey of the said Land returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL, which said tract has been located in satisfaction of the above mentioned Warrant, in pursuance of the Act of Congress above mentioned, approved February 11th, 1847. TO HAVE AND TO HOLD the said *part of said* section of land, with the appurtenances thereof, unto the said *John W. Mayberry, and to his*

heirs and assigns forever.

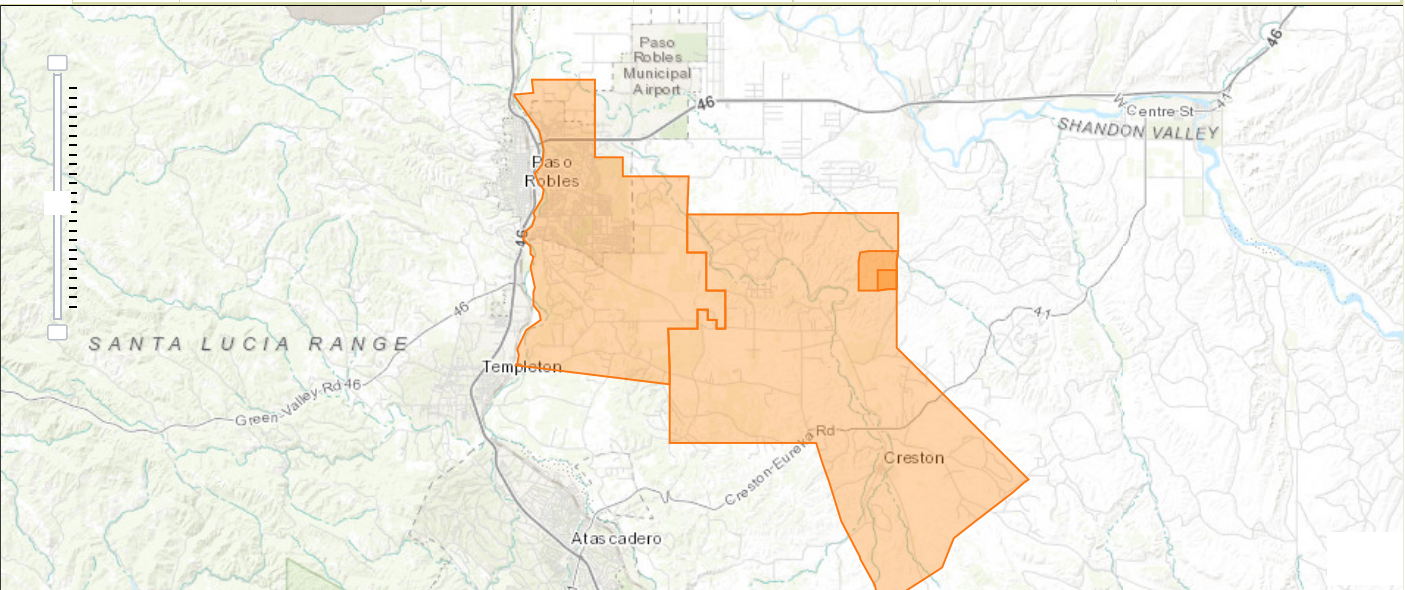
