OFFICE at San Francisco whereby it appears that full payment has been made by the said

Francisco County California containing thirty seven acres and
seventy five hundredths of an acre

according to the official plat of the Survey of the said Lands, returned to the General Land Office by the SURVEYOR GENERAL,

United States of America, in consideration of the premises, and in conformity with the several acts of Congress in such case
made and provided, HAVE GIVEN AND GRANTED, and by these presents DO GIVE AND GRANT, unto the said

Philip Biddel

and to his heirs, the said tract above described: To have and to hold the same, together with all the rights, privileges,
immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said Philip Biddel

and to his heirs and assigns forever.

of the GENERAL LAND OFFICE to be hereunto affixed.

in the year of our Lord one thousand eight hundred and sixty one and of the
INDEPENDENCE OF THE UNITED STATES the eighty fifth
