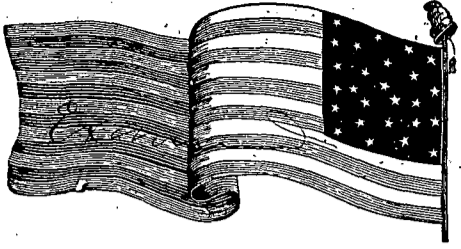

THE UNITED STATES OF AMERICA,

To all to whom these Presents shall come, Greeting:

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the **GENERAL LAND OFFICE**, Warrant No. *57718* for *160.* acres, in favor of *George W. Bellamy, Private, Captain Aramis' Company California Volunteers, War. with Mexico.*

with evidence that the same has been duly located upon *the South half of the South East quarter of Section Three; and the East half of the North East quarter of Section Ten, in Township Twenty seven South of Range Fifteen East Mt Diablo Meridian, in the district of lands subject to sale at San Francisco, California, containing one hundred and sixty acres.*

according to the Official Plat of the Survey of said Lands returned to the **GENERAL LAND OFFICE** by the **SURVEYOR GENERAL** *the said Warrant having been assigned by the said George W. Bellamy to Charles Parr and by him to Francisco Cassanova, and by him to James T. Bacham, and by him to Patrick Dunn and by him to Phillip Biddel in whose favor said tract has been located*

NOW KNOW YE, That there is therefore granted by the **UNITED STATES** unto the said *Phillip Biddel as assigned as aforesaid and his heirs*

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said *Phillip Biddel as assigned as aforesaid and his*

heirs and assigns forever.

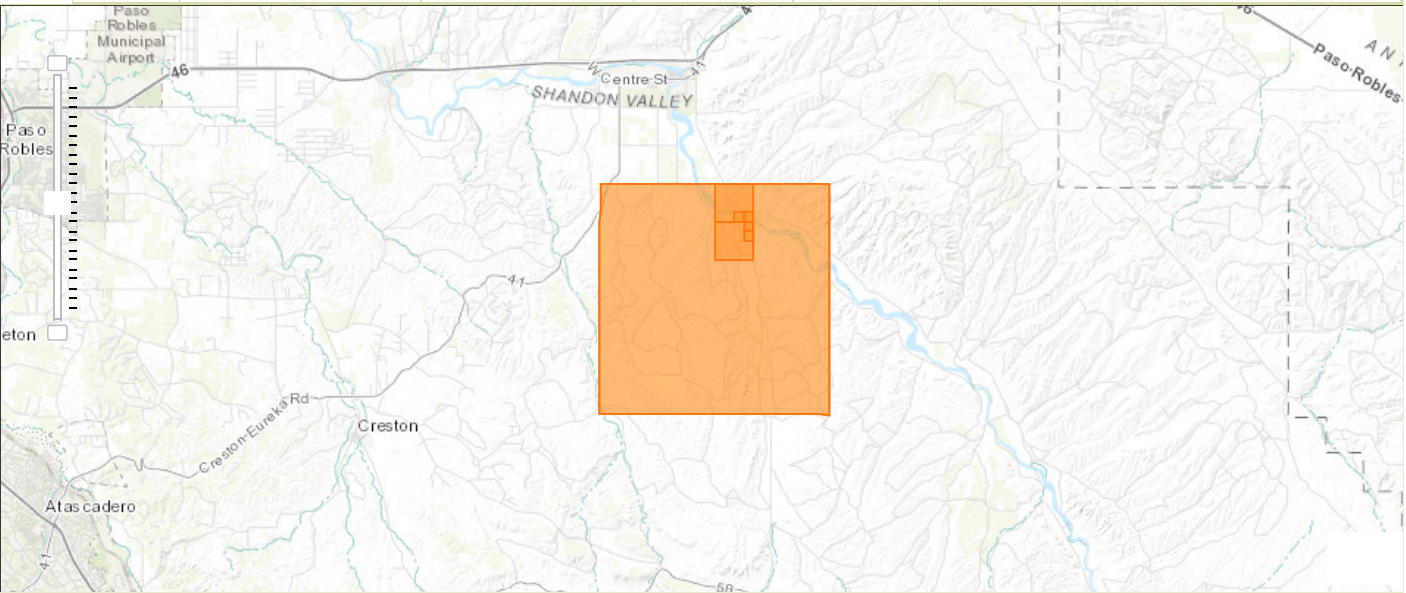
