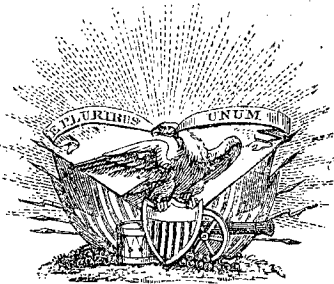

To all to whom these Presents shall come, Greeting:

Whereas, In pursuance of the Act of Congress, approved September 28th, 1850, entitled "An Act granting Bounty Land to certain Officers and Soldiers who have been engaged in the Military Service of the United States," Warrant No. 11499, for 140, acres, issued in favor of John Larson, Private, Captain Howie's Company, 2^d Regiment United States Dragoons, Florida War, having been assigned by the said John Larson to Robert G. Flint, and

has been returned to the GENERAL LAND OFFICE, with evidence that the same has been duly located upon the South West quarter of the South West quarter of section Twenty six, the South half of the South East quarter of section Twenty seven, and the North West quarter of the North East quarter of section Thirty four, in Township Twenty seven South, of Range Sixteen East, Mt. Diablo Meridian, in the District of lands subject to sale at San Francisco, California containing one Hundred and Sixty acres, according to the Official Plat of the Survey of the said Lands returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL:

Now Know Ye, That there is therefore granted by the UNITED STATES unto the said

the Tract of Land above described: TO HAVE AND TO HOLD the said Tract of Land, with the appurtenances thereof, unto the said *Robert G. Flint*, and to his

heirs and assigns forever.

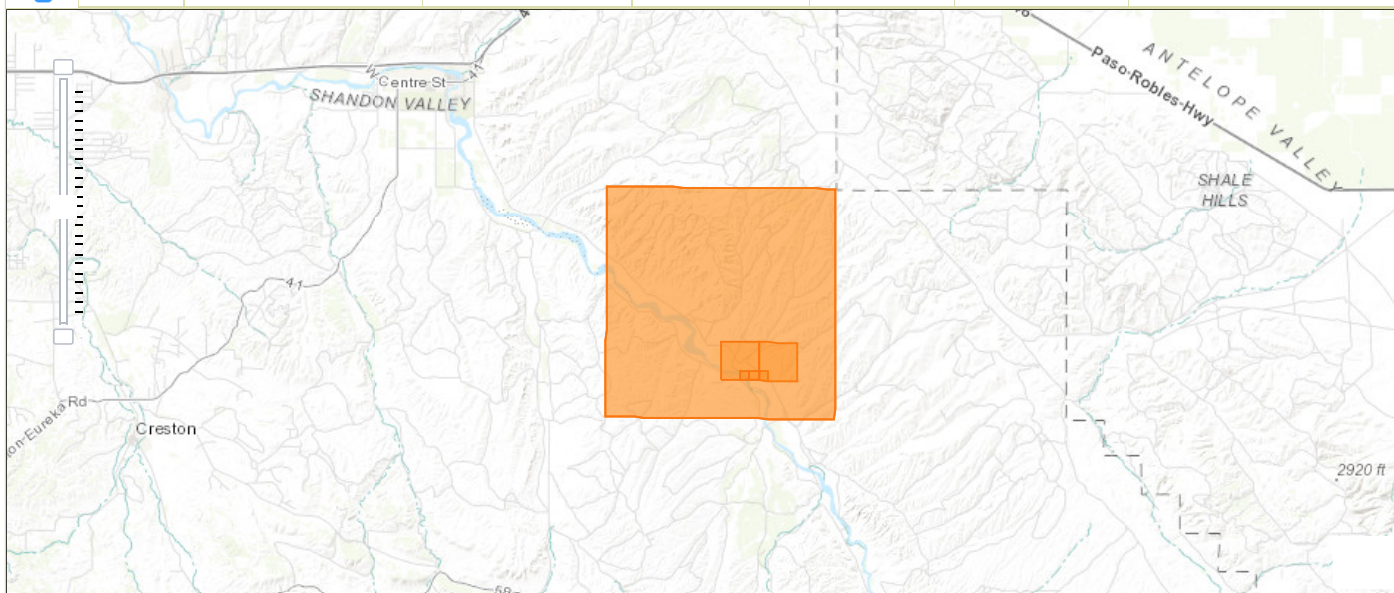
