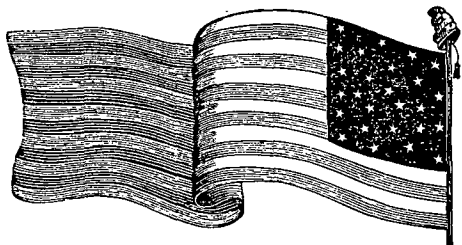

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE,

Warrant No. *31 551* for *80* acres, in favor of *Eliza W. Graves, widow of Thomas H. Graves Private Captain West's company Kentucky Militia War 1812*

with evidence that the same has been duly located upon *the West half of the south West quarter of Section twenty one in Township twenty seven south of Range sixteen east of the Mount Diablo Meridian in the district of lands subject to sale of San Francisco California* containing *eighty* acres

according to the Official Plat of the Survey of said Lands returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL

the said warrant having been assigned by the said Eliza W. Graves to John D. Thompson in whose favor said tract has been located

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said

John D. Thompson as of right as aforesaid and to his heirs

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said

John D. Thompson as of right as aforesaid and to his

heirs and assigns forever.

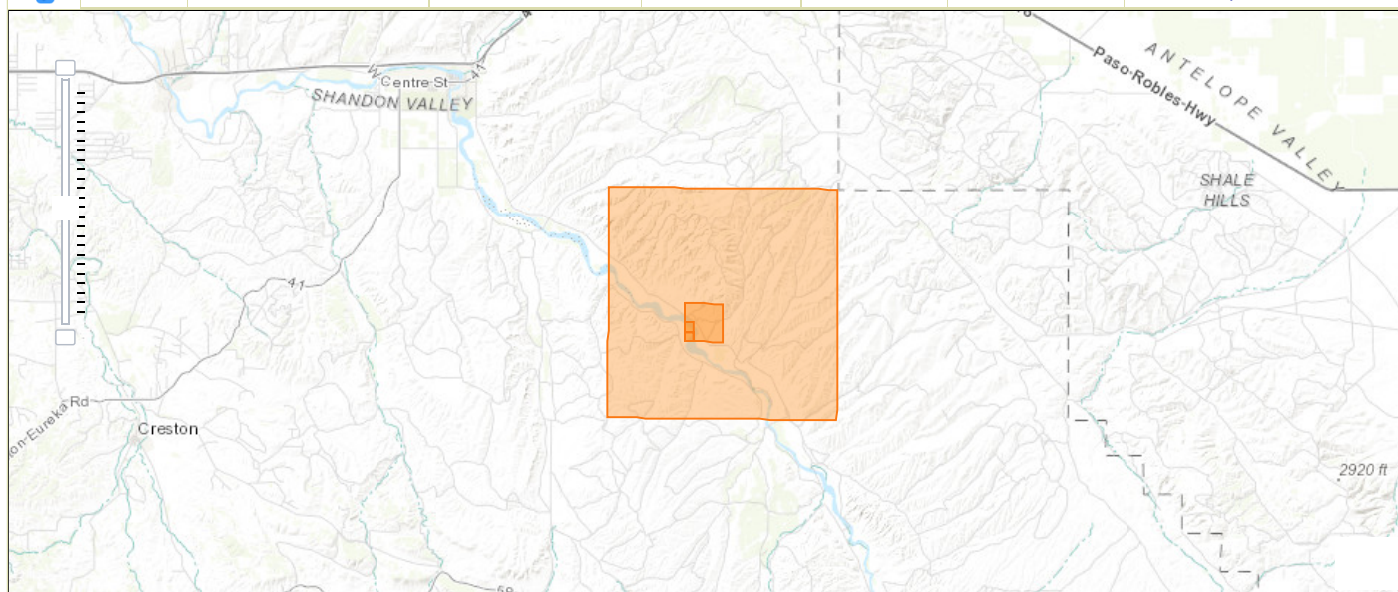
