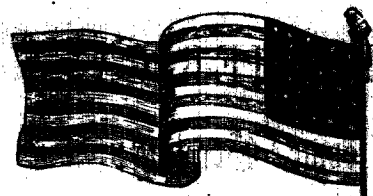

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1856, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the **GENERAL LAND OFFICE,**

Warrant No. *71,906* for *160* acres, in favor of

*Adam Johnson, Private Captain Cavalry
Company K. 1st Regiment U.S. Dragoons, Apache
Indian Disturbance*

with evidence that the same has been duly located upon *the West half of the North West quarter
of Section thirty five, and the East half of the North East quarter of
Section thirty four, in Township twenty seven, South, of Range
sixteen, East, Mount Diablo Meridian, in the District of
lands subject to sale at San Francisco, California, con-
taining one hundred and sixty acres*

according to the Official Plat of the Survey of said Lands returned to the **GENERAL LAND OFFICE** by
the **SURVEYOR GENERAL** *the said tract having been signed by the said Adam Johnson to Michael
Gagnon, by him to Mary Ann L. Whybark, and by her to Robert G. Flint, in whose
favor said tract has been located*

NOW KNOW YE, That there is therefore granted by the **UNITED STATES** unto the said
Robert G. Flint, as Assignee, as aforesaid, and to his heirs

the tract of Land above described: **TO HAVE AND TO HOLD** the said tract of Land, with the appurtenances
thereof, unto the said *Robert G. Flint, as Assignee, as aforesaid, and
his heirs*

and the **SEAL OF THE GENERAL LAND OFFICE** to be hereunto affixed.
