THE UNITED STATES OF AMERICA

To all to whom these Presents shall come, Greeting:

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE, Warrant No. *11,373* for *160* acres in favor of *James Kenox, Corporal, Captain Haywoods Company, Tennessee Militia, Florida War,*

with evidence that the same has been duly located upon *the South half of the North West quarter, and the East half of the South West quarter, of section Twenty one, in Township Twenty eight, South, of Range Ten, East, in the District of lands subject to sale at San Francisco, California, containing One Hundred and sixty acres.*

according to the Official Plat of the Survey of said Lands returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL *the said Warrant having been assigned by the said James Kenox, to Thomas J. Beckett, in whose favor said tract has been located.*

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said *Thomas J. Beckett, as assignee, as aforesaid and to his heirs.*

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said *Thomas J. Beckett, as assignee, as aforesaid and to his*

heirs and assigns forever.

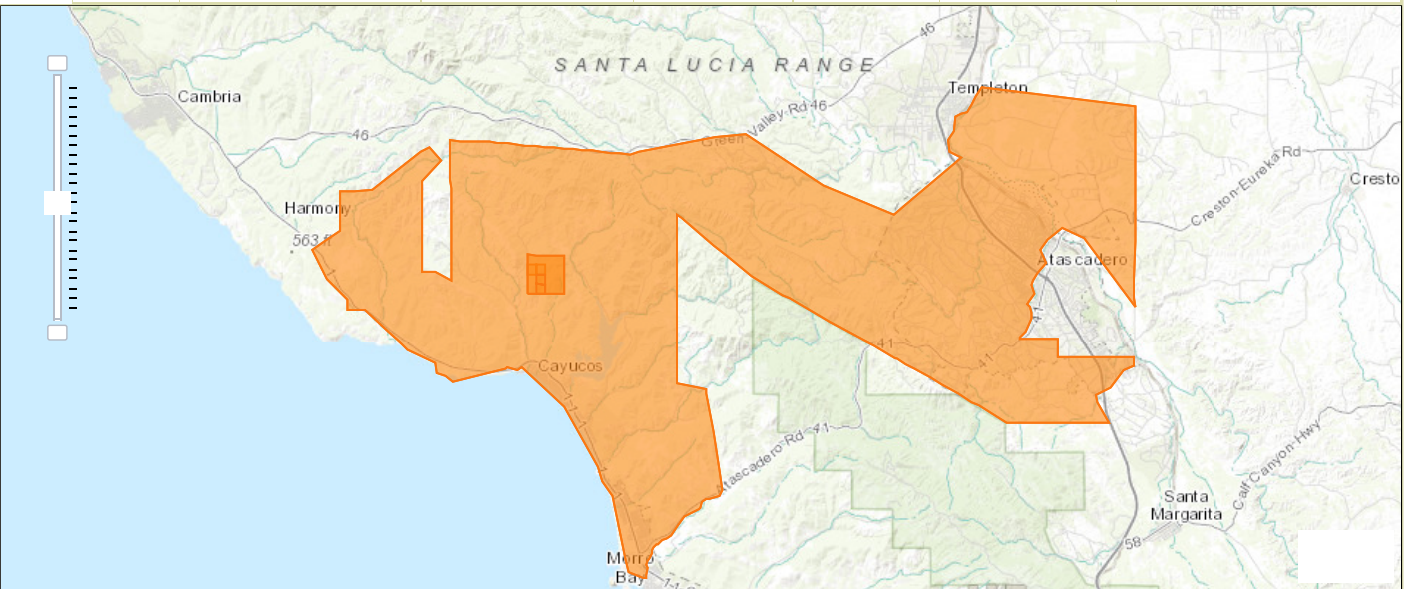
