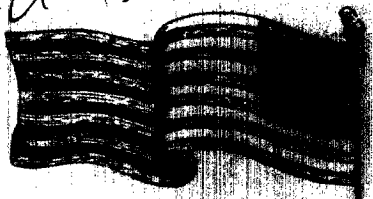

# THE UNITED STATES OF AMERICA,

To all to whom these Presents shall come, Greeting:

**WHEREAS,** In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE,

Warrant No. *107599* for *160* acres in favor of *Henry Osborne Ship*  
*Corporal Captain Montgomery, U.S. Ship Portsmouth, War with Mexico.*

with evidence that the same has been duly located upon *the East half of the South West quarter, of Section*  
*Twenty two, the North East quarter of the North West quarter, and the ~~South~~ West quarter,*  
*of the North East quarter, of Section Twenty seven, in Township Twenty eight, ~~North~~ South,*  
*Range Ten East, in the District of lands subject to sale at San Francisco, California,*  
*containing One Hundred and Sixty acres.*

according to the Official Plat of the Survey of said Lands returned to the GENERAL LAND OFFICE by  
 the SURVEYOR GENERAL *the said Warrant having been assigned by the said Henry Os-*  
*borne to Walter S. Church, Junior, and by him to Young & Selby, in whose favor*  
*said Tract has been located.*

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said  
*Young & Selby, as assignee, as aforesaid and to his heirs.*

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances  
 thereof, unto the said *Young & Selby, as assignee as aforesaid and to his*

heirs and assigns forever.

 PRESIDENT OF THE UNITED STATES OF AMERICA, have caused these Letters to be made Patent,  
 and the SEAL OF THE GENERAL LAND OFFICE to be hereunto affixed.

 of *November* in the year of our Lord one thousand  
 eight hundred and *seventy one*, and of the INDEPENDENCE  
 OF THE UNITED STATES the *thirty sixth*
