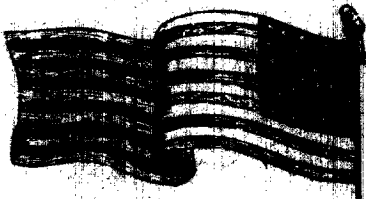

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE,

Warrant No. 108856 for 160 acres, in favor of Sarah Woodbury, Widow,
of Peter Woodbury, Private, Captain Lyster's Company, Massachusetts Militia, War of 1812.

with evidence that the same has been duly located upon the East half of the North East quarter, the South West-
quarter of the North East quarter, and the North West quarter of the South East quarter, of Section Twenty
two, in Township Twenty eight, South of Range Ten, East, in the District of lands subject to sale at
San Francisco, California, containing One Hundred and Sixty acres.

according to the Official Plat of the Survey of said Lands returned to the **GENERAL LAND OFFICE** by
the SURVEYOR GENERAL the said Warrant having been assigned by the said Sarah Woodbury,
to Samuel J. Beckett, in whose favor said Tract has been located

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said
Samuel J. Beckett, as assignee, as aforesaid and to his heirs,

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances
thereof, unto the said Samuel J. Beckett, as assignee, as aforesaid and to his

heirs and assigns forever.
