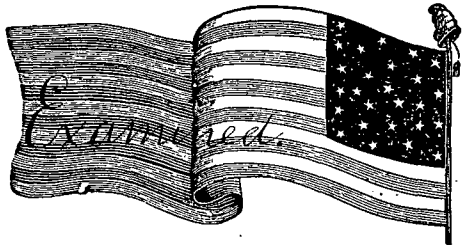

To all to whom these Presents shall come, Greeting:

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE,

Warrant No. *92,190* for *160* acres, in favor of *Elijah Frost*
Private Captain Pugh's Company Oregon Militia Cayuse War.

with evidence that the same has been duly located upon *the south-west quarter, and the East half of the North West quarter of Section the South West quarter of Section Twelve and the North East quarter of the North West quarter of Section Thirteen in Township Twenty Eight South of Range Sixteen East Mount Diablo Meridian in the District of Lands subject to sale at San Francisco California, containing one hundred and fifty acres.*

according to the Official Plat of the Survey of said Lands returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL *the said Warrant having been assigned by the said Elijah Frost to John McDowell and by him to Robert G. Flint in whose favor said tract has been located.*

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said *Robert G. Flint as assignee as aforesaid and to his heirs*

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said *Robert G. Flint as assignee as aforesaid and to his*

heirs and assigns forever.

PRESIDENT OF THE UNITED STATES OF AMERICA, have caused these Letters to be made Patent, and the SEAL OF THE GENERAL LAND OFFICE to be hereunto affixed.

GIVEN under my hand, at the CITY OF WASHINGTON, the *fifth* day of *November* in the year of our Lord one thousand eight hundred and *Sixty two*, and of the INDEPENDENCE OF THE UNITED STATES the *Eighty seventh*
