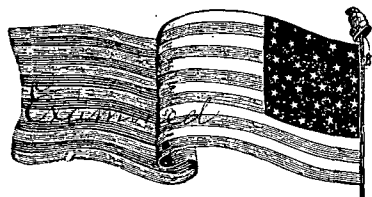

To all to whom these Presents shall come, Greeting:

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE, Warrant No. 92,683 for 100 acres, in favor of Joseph Loud, ordinary seaman, Ship Mississippi, ~~United States~~ U. S. States Navy, War with Mexico

with evidence that the same has been duly located upon the South-West quarter of the South-West quarter of Section one, and the South half of the South-East quarter of Section two, and the North-East quarter of the North-East quarter of Section eleven, in Township twenty-eight South of Range sixteen East of Mt. Diablo meridian, in the district of lands subject to sale at San Francisco, California, containing one hundred and sixty acres.

according to the Official Plat of the Survey of said Lands returned to the GENERAL LAND OFFICE by the SURVEYOR GENERAL - the said Warrant having been assigned by the said Joseph Loud to Robert G. Flint, in whose favor the said tract has been located.

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said Robert G. Flint, as assignee as aforesaid, and to his heirs,

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances thereof, unto the said Robert G. Flint, as assignee as aforesaid, and to his

heirs and assigns forever.

PRESIDENT OF THE UNITED STATES OF AMERICA, have caused these Letters to be made Patent, and the SEAL OF THE GENERAL LAND OFFICE to be hereunto affixed.



GIVEN under my hand, at the CITY OF WASHINGTON, the first day of July, in the year of our Lord one thousand eight hundred and sixty-one, and of the INDEPENDENCE OF THE UNITED STATES the eighty-fifth.

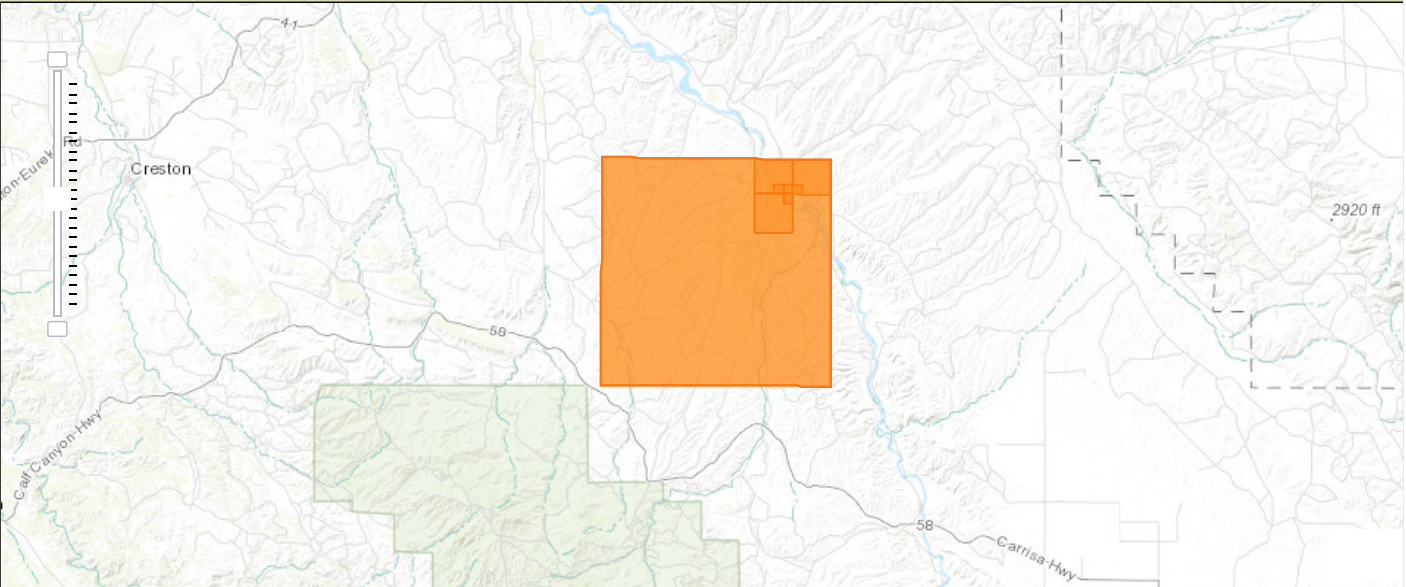
