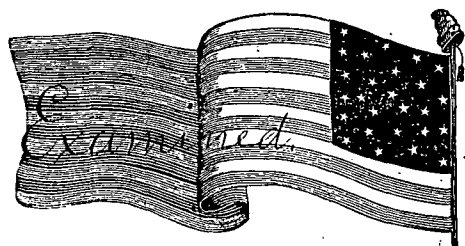

To all to whom these Presents shall come, Greeting:

WHEREAS, In pursuance of the Act of Congress, approved March 3, 1855, entitled "An Act in addition to certain Acts granting Bounty Land to certain Officers and Soldiers who have been engaged in the military service of the United States," there has been deposited in the GENERAL LAND OFFICE,

Warrant No. *95447* for *120* acres, in favor of *John S. Henry*
Sergeant Captain Stevenson's Company Illinois Militia Black
Honor. War.

with evidence that the same has been duly located upon *the South half of the North East quarter*
of Section twenty three and the North West quarter of Section twenty three
in Township thirty South of Range seventeen East Mount Diablo Meridian in
the District of Lands subject to sale at San Francisco, California, containing
one hundred and twenty acres.

according to the Official Plat of the Survey of said Lands returned to the **GENERAL LAND OFFICE** by
 the SURVEYOR GENERAL *the said warrant having been assigned by the said John*
S. Henry to Dr. W. James in whose favor said tract has been
located

NOW KNOW YE, That there is therefore granted by the UNITED STATES unto the said
Dr. W. James as assignee as aforesaid and to his heirs

the tract of Land above described: TO HAVE AND TO HOLD the said tract of Land, with the appurtenances
 thereof, unto the said *Dr. W. James as assignee as aforesaid and to his*

heirs and assigns forever.

 and the SEAL OF THE GENERAL LAND OFFICE to be hereunto affixed.

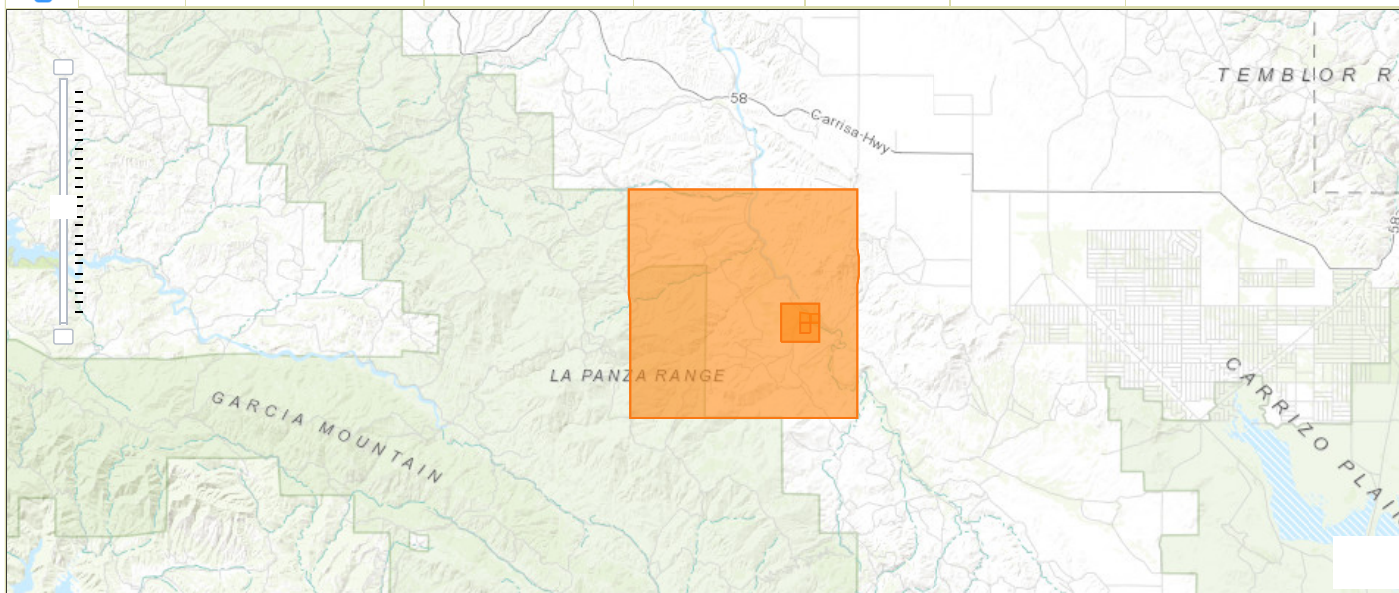
