Granted by Alvarado Sept. 28, 1838 to Juan Bandini. Claim filed by Bandini Sept. 25, 1852, for part of the grant; patent issued to **Abel Stearns** May 23, 1879, for 32,259.16 acres (28,143.53 acres in Riverside County; 4,115.63 acres in San Bernardino County). Commission 361, Expediente 203. The patent is recorded in San Bernardino, No. 483 General Land Office map. (The grant was **also called Guapa, or Huapa**, and later was known as Agua Mansa.)
